

<u>Purpose/Objectives:</u> In addition to discussion of conducting and issues inherent to the practice of conducting, the class also serves as an ensemble. This will enable students to experience conducting conditions. Points under discussion are illustrated in the context of actual musical experience where the validity of any hypothesis can be immediately tested. This study will lead to the development and enrichment of the knowledge regarding wind, string, and percussion literature.

#### **Student Learning Outcomes:**

- The student will demonstrate clear, efficient, and expressive conducting technique.
- The student will demonstrate knowledge of standard instrumental repertoire appropriate for groups of varying capabilities and maturity.
- The student will demonstrate adequate error detection in rehearsal, and various rehearsal strategies for correction.

#### **Grading and Attendance Policy:**

The final grade will be assigned based on scores from four (4) musical terminology exams, three (3) literature listening exams, a survey of conductors assignment, an instrument transposition exam, a score analysis exam, a written document, two (2) ear-training exams, a two (2) conducting exams, completion of a knowledge learning chart (K-W-L), and a comprehensive final exam.

These elements will be weighted as follows:

Survey of conductors = 100 points

Terminology exams (4) = 60 points each (240 points)

Literature listening exam #1 & #2 = 40 points each (80 points)

Literature listening exam #3 = 50 points

Instrument transposition exam = 100 points

Ear-training exam #1 & #2 = 50 points each (100 points)

Score analysis exam= 100 points

Written document = 100 points

Conducting exam #1 & #2 = 100 points each (200 points)

Comprehensive Final Exam = 200 points (10:00 am - Wednesday - May 14)

Each student is allowed two (2) absences during the semester with no questions asked. Beginning with the third ( $3^{rd}$ ) absence, the overall final grade will be lowered by one (1) letter per absence. **Make up testing will not be offered.** Assignments are due on the date specified. Absence from class on an assignment due-date does not excuse a student from turning in the assignment. Late assignments will be reduced one grade for each late day.
